***Resolution on Protecting the Progress Enacted during President Obama's First Two Years in Office***

**WHEREAS**, on January 20, 2009, Barack Obama was sworn in as America's 44<sup>th</sup> President during a time of great American challenges and, working in concert with Congressional Democrats, immediately set about to find solutions to those challenges; and

**WHEREAS**, President Obama implemented the Post-9/11 GI Bill, increasing educational opportunities for veterans by making college more affordable for returning service members; and

**WHEREAS**, President Obama nominated and oversaw the confirmation of two United States Supreme Court Justices, including the first Latina Justice, and brought the total number of women sitting on the Supreme Court to an historic and unprecedented three; and

**WHEREAS**, President Obama set new emissions and fuel efficiency standards for American cars and light trucks and made historic investments in clean energy technologies that are helping to pave the way to a more sustainable future; and

**WHEREAS**, President Obama increased America's national security by ending combat operations in Iraq, concluding the New START Treaty that renews America's leadership in pursuit of a world without nuclear weapons, and pursuing a new strategy for Afghanistan and Pakistan; and

**WHEREAS**, President Obama advanced civil rights by repealing "Don't Ask, Don't Tell" and enacting the Lilly Ledbetter Fair Pay Act to make it easier for women to challenge unfair pay practices; and

**WHEREAS**, those accomplishments amount to the most productive and progressive period of American governance since President Franklin Delano Roosevelt; and

**WHEREAS**, Republicans are trying to take back that progress, working to repeal health insurance reform and other critical reforms rather than partnering with Democrats to find bipartisan solutions to create jobs, grow the economy, and make America more competitive;

**THEREFORE BE IT RESOLVED**, that the Democratic National Committee congratulates President Obama and Democrats of the 111th Congress for passing meaningful, fair, and comprehensive legislation and successfully pursuing an agenda that strengthens America both at home and abroad; and

**BE IT FURTHER RESOLVED**, that the Democratic National Committee stands committed to protecting the progress that President Obama and Democrats in Congress have made and opposing Republican efforts to repeal that progress.

***Resolution on the Economic Recovery***

**WHEREAS**, President Obama inherited the worst recession since the Great Depression, taking office at a time when the economy was losing nearly 800,000 jobs a month, when the banking system was in crisis, and when the credit markets were essentially frozen; and

***Resolution on the Republican Effort to Repeal the Affordable Care Act***

**WHEREAS**, President Barack Obama and Democrats in Congress succeeded in their historic efforts to pass health insurance reform over the united opposition of Republicans and insurance companies; and

**WHEREAS**, the resulting law, known as the Affordable Care Act, expands health insurance coverage to 32 million Americans, guarantees that more than 24.1 million young adults 26 or younger can stay on their parents' coverage, offers health care tax credits to more than 6.7 million American small businesses, and makes life-saving medication more affordable for the more than 3.7 million seniors who will benefit from the closing of the Medicare Part D coverage gap; and

**WHEREAS**, the Affordable Care Act prevents insurance companies from discriminating against Americans with pre-existing conditions, a category of individuals that the Department of Health and Human Services estimates includes as many as 129 million Americans under the age 65; and

**WHEREAS**, the Affordable Care Act frees families from the hazard of coverage caps that kick in when insurance is most needed and from the threat of unjustifiable or sudden premium increases; and

**WHEREAS**, the Affordable Care Act provides people the freedom to change jobs or start their own businesses without the fear of losing their coverage; and

**WHEREAS**, the Affordable Care Act gives seniors the freedom to get the care they need, including free preventive care, more affordable prescription drugs, and Medicare that they can count on; and

**WHEREAS**, the Affordable Care Act helps small business owners to compete with large employers by increasing their purchasing power through competitive private health insurance exchanges; and

**WHEREAS**, the Affordable Care Act frees our children from the threat of ever-increasing deficits by holding government accountable for its spending; reducing the deficit by a trillion dollars by cracking down on waste, fraud and abuse; and stopping hundreds of billions in unfair and irresponsible subsidies to insurance companies; and

**WHEREAS**, Republicans are working to take away those benefits and patient protections, in the face of public support for the law and in direct contradiction of Republicans' pledge to prioritize efforts to find bipartisan solutions to create jobs, grow the economy, and increase American competitiveness; and

**WHEREAS**, Republicans have already approved legislation repealing the Affordable Care Act in the House of Representatives and continue to challenge the new law in the courts as well as in Congress;

**THEREFORE BE IT RESOLVED**, that the Democratic National Committee applauds President Barack Obama and Democrats in Congress for enacting health insurance reform that guarantees all Americans affordable, quality health coverage; and

**BE IT FURTHER RESOLVED**, that the Democratic National Committee condemns Republicans' partisan efforts to repeal the Affordable Care Act against the wishes of the American people and pledges its support to the President and Democrats in Congress as they work to defend this critical legislation.

***Resolution on the Repeal of “Don’t Ask, Don’t Tell”***

**WHEREAS**, the United States maintains that all men and women are created equal and welcomes the service of every individual; and

**WHEREAS**, enabling Americans to serve in the military regardless of their sexual orientation is in keeping with those ideals; and

**WHEREAS**, the Pentagon has found that there is no compelling reason for preventing Americans from undertaking military service on the basis of their sexual orientation and has further found that the sexual orientation of America’s service members is of no relation to the level of honor, integrity, and courage they bring to their work; and

**WHEREAS**, “Don’t Ask Don’t Tell” is an outdated and discriminatory policy that does not reflect American values, does not support American national security, and does not bear on the capacity of the United States military to fulfill its mission; and

**WHEREAS**, the President of the United States, the Secretary of Defense, the Chairman of the Joint Chiefs, a majority of Americans, and a majority of service members therefore voiced their support for the repeal of “Don’t Ask, Don’t Tell,” and Congress duly approved its repeal; and

**WHEREAS**, the repeal of “Don’t Ask, Don’t Tell” reaffirmed the principles of equality and justice that define our nation and made it clear that those principles are not limited on the basis of sexual orientation or of any other quality, but extend to all Americans without limitation;

**THEREFORE BE IT RESOLVED**, that the Democratic National Committee applauds President Obama and Democrats in Congress on their historic repeal of the discriminatory “Don’t Ask Don’t Tell” policy.

***Resolution Honoring the Victims, Heroes and Survivors from Tucson***

**WHEREAS**, Representative Gabrielle Giffords is a 3rd term representative from Arizona's 8th Congressional District who was the subject of an assassination attempt on Saturday January 8, 2011 at 10:10am, while hosting her well-known Congress On Your Corner event; and

**WHEREAS**, Gabe Zimmerman, Representative Gifford's Community Outreach Director, was shot and killed at the same January 8th event; and

**WHEREAS**, 9 year old Christina Taylor Green, 76 year old Dorothy Morris, 63 year old Federal Judge John Roll, 79 year old Phyllis Schneck, and 76 year old Dorwan Stoddard, were also shot and killed while innocently participating alongside Representative Giffords; and

**WHEREAS**, Staffers Ron Barber and Pamela Simon, along with 13 other guests and bystanders were injured, in some cases while risking their own lives coming to the aid of others; and

**WHEREAS**, 5-day Intern, Daniel Hernandez, Jr, immediately came to the aid of those injured, including Representative Giffords, with actions that likely saved many lives, including the congresswoman's;

**THEREFORE BE IT RESOLVED**, that the Democratic National Committee extend sincere condolences to the family and friends of those whose lives were needlessly cut short; express our continued desire to see Representative Giffords continue in her seemingly miraculous recovery and her eventual return to the halls of Congress; extend prayers, well wishes, thoughts and positive energy, to all those who are still recovering both in the hospital and at home; commend Daniel Hernandez Jr. for his act of bravery and heroism, despite his rejection of that term; recognize the courageous efforts of the Police, Fire, Ambulance, and all the First Responders, whose quick and noble actions minimized the casualties; and will strive to, as inspired by

President Obama's words, "...do everything we can to make sure this country lives up to our children's expectations".

***Resolution Honoring Representative Gabrielle Giffords and Recognizing other Victims of the Tragedy in Arizona***

**WHEREAS**, United State Representative Gabrielle Giffords has devoted much of her adult life to her passion for public service and efforts to improve her community by serving first in the Arizona House and Senate, and later in the United States Congress; and

**WHEREAS**, Rep. Giffords has been a tireless advocate for the people of Southern Arizona, working to advance job and energy creation from solar and other renewable forms of energy, secure the border and protect our communities, promote job creation, innovation and economic competitiveness, advocate fiscal responsibility and debt and deficit reduction, and expand access to health care to people of all ages; and

**WHEREAS**, Rep. Giffords is loved and admired by all who know her, from both sides of the aisle, for her intelligence, dedication to her constituents, and warm personality; and

**WHEREAS**, on January 8, 2011, an armed gunman opened fire at a 'Congress on Your Corner' event hosted by Representative Gabrielle Giffords in Tucson, Arizona, killing 6 and wounding at least 14 others; and

**WHEREAS**, Christina Taylor Green, Dorothy Morris, John Roll, Phyllis Schneck, Dorwan Stoddard, and Gabriel Zimmerman lost their lives in this attack; and

**WHEREAS**, 14 others were also wounded in the shooting, including Ron Barber and Pamela Simon, both staffers to Representative Giffords; and

**WHEREAS**, Gabriel Zimmerman was Outreach Director and Constituency Services Director for U.S. Representative Gabrielle Giffords and his death represents the first time in the history of Congress in which a Congressional aide has been killed in the performance of the official functions of a Congressional office;

**WHEREAS**, several individuals, including Patricia Maisch, Army Col. Bill Badger (Retired), who was also wounded in the shooting, Roger Sulzberger, Joseph Zimudio, and Daniel Hernandez, Jr., helped apprehend the gunman and assist the injured, thereby risking their lives for the safety of others, and should be commended for their bravery; and

**WHEREAS**, thanks to Mr. Hernandez's first aid training and the efforts of countless first responders, nurses, and doctors, Rep. Giffords miraculously survived a serious brain injury and her condition continues to improve every day;

**THEREFORE BE IT RESOLVED**, that the Democratic National Committee family is heartened by the wonderful news of Rep. Giffords' progress and sends their love and encouragement to the Houston, TX facility where she continues to fight to make a full recovery; and

**BE IT FURTHER RESOLVED**, that the Democratic National Committee continues to honor the sacrifice of those who were injured and lost and sends its sincere condolences to family and friends affected by the tragedy.

***Resolution Celebrating the New START Treaty***

**WHEREAS**, Measures for the Further Reduction and Limitation of Strategic Offensive Arms – a measure more commonly known as the “Strategic Arms Reduction Treaty,” or the “New START,” is a bilateral treaty between the United States of America and the Russian Federation to reduce the number of nuclear arms between the two countries and build mutual trust, openness, predictability, and cooperation; and

**WHEREAS**, New START was negotiated in the interest of international peace and security and was the culmination of extensive talks between U.S. and Russian delegations in Geneva led by Assistant Secretary Rose Gottemoeller of the U.S. State Department and Anatoly Antonov from the Russian Ministry of Foreign Affairs, and was predicated on the treaty for the Non-Proliferation of Nuclear Weapons of 1968, the 1991 START I Treaty, the START II Treaty, the 2002 Treaty of Moscow (SORT) and with respect to decades of negotiations to advance nuclear disarmament; and

**WHEREAS**, within seven years of the execution of the New START treaty the United States and the Russian Federation will reduce the number of deployed strategic nuclear weapons including inter-continental ballistic missile launchers, submarine-launched ballistic missile launchers, and heavy bombers and will re-implement a system of arms inspection, monitoring and inventory management that will help to prevent theft of unsecured fissile material that could fuel a nuclear terrorist attack; and

**WHEREAS**, reducing nuclear arms between the parties will enhance the safety and security of the nations and the global community – not diminish it; and

**WHEREAS**, the treaty will last ten years, with an option to renew it for up to five years upon agreement of both parties; and

**WHEREAS**, the New START Treaty was signed by the President of the United States Barack Obama and the President of the Russian Federation Dmitry Medvedev in Prague on April 8, 2010, and was ratified on the advice and consent of the U.S. Senate on December 22, 2010 by a bi-partisan vote of 71 to 26 – with the support of thirteen Republican Senators who crossed party lines to ratify the treaty and endorsements from former President George H. W. Bush and all six former Republican Secretaries of State; and

**WHEREAS**, President Medvedev introduced the proposed treaty for consideration in Russia’s lower house of parliament on May 28, 2010, and that the whole of the Federal Assembly of Russia may approve the treaty by a majority vote in early 2011; and

**WHEREAS**, the New START treaty will be executed upon the exchange of instruments of ratification between the U.S. and the Russian Federation;

**THEREFORE BE IT RESOLVED** that the Democratic National Committee fully supports the New START Treaty and commends President Obama, the United States Senate, President Medvedev and the Federal Assembly of Russia for ratifying the treaty in an effort to advance nuclear non-proliferation around the world and make our global community a safer place.

***Resolution on Protecting a Woman’s Right to Choose***

**WHEREAS**, the Democratic Party has been a consistent champion of the reproductive choices guaranteed to women by the 1973 *Roe v. Wade* Supreme Court decision; and

**WHEREAS**, this January marked the 38<sup>th</sup> anniversary of that Supreme Court decision and of the ability of women across the country to obtain safe, legal health care regardless of their reproductive choices; and

**WHEREAS**, the Democratic Party has consistently defended women’s reproductive choices in the face of Republican attacks, including Republican efforts to circumscribe the health care options available to women in the aftermath of a sexual attack, incest, or other trauma; and

### ***Resolution on Redistricting and the Voting Rights Act***

**WHEREAS**, the right to vote is fundamental, and protects and preserves all other civil and political freedoms; and

**WHEREAS**, the U.S. Constitution created the world's first government founded on the consent of the governed, endowing the young republic with an electoral system based in legislative representation; and

**WHEREAS**, the Fourteenth Amendment to the Constitution guarantees that all Americans are entitled to equal protection under law, and provides that Members of the House of Representatives shall be apportioned among the states according to their population; and

**WHEREAS**, in our federal system, states have the primary duty to administer elections and state legislatures are entrusted with the responsibility to draw the boundaries of legislative districts for federal and state representatives in the process known as redistricting; and

**WHEREAS**, redistricting is an opportunity to ensure fair representation in the political process, that the voices of all Americans are heard equally, and that every eligible citizen can fully exercise his or her fundamental right to vote; and

**WHEREAS**, in some of its most insidious uses, the redistricting process has been employed to restrict the political participation of African-Americans, Latinos and other racial and ethnic

minorities, diluting their voting strength either by packing unnecessarily large numbers of minority communities into supermajority districts to limit the number of minority-controlled seats, or by diluting the strength of minority voters by cracking or splintering cohesive groups of communities of color; and

**WHEREAS**, the Supreme Court has recently observed that “racial discrimination and racially polarized voting are not ancient history” and that “[m]uch remains to be done to ensure that citizens of all races have equal opportunity to share and participate in our democratic processes and traditions...,” and<sup>1</sup>

**WHEREAS**, the Supreme Court of the United States, writing through Chief Justice Earl Warren, has said “The right to vote freely for the candidate of one’s choice is of the essence of democratic society, and any restrictions on that right strike at the heart of representative government. And the right of suffrage can be denied by a debasement or dilution of the weight of a citizen’s vote just as effectively as by wholly prohibiting the free exercise of the franchise;”<sup>2</sup> and

**WHEREAS**, the Supreme Court has held that “[A]ll who participate in the election are to have an equal vote – whatever their race, whatever their sex, whatever their occupation, whatever their income . . . The conception of political equality from the Declaration of Independence, to Lincoln’s Gettysburg Address, to the Fifteenth, Seventeenth, and Nineteenth Amendments can mean only one thing – one person, one vote;”<sup>3</sup> and

**WHEREAS**, inspired by the sacrifices of generations of American civil rights activists, Congress passed the Voting Rights Act of 1965, which prohibits laws or practices, including those redistricting plans, that deny minority voters an equal opportunity to participate in the political process and to elect representatives of their choice; and

**WHEREAS**, the Voting Rights Act and the Supreme Court’s “one person, one vote” jurisprudence have made operable the Constitutional protections accorded to the fundamental right to vote, greatly improving the legal protections for the African-American, Latino and other racial and ethnic minority communities in the redistricting process; and

**WHEREAS**, in 2011 and 2012, state legislatures, independent commissions, and political leaders in state legislatures across the country will convene for the next round of redistricting, drawing legislative maps that will shape federal and state elections over the next decade; and

**WHEREAS**, Democrats believe that the redistricting process must allow each state's electorates the full freedom of political participation and ensuring that legislative districts are drawn to protect the voice of every American;

**THEREFORE, BE IT RESOLVED**, that the Democratic National Committee calls on state legislatures, independent commissions and other leaders to draw state and federal legislative districts in accordance with the Equal Protection Clause, with fidelity to the principle of “one person, one vote,” and in recognition of the fundamental importance of the right to vote in our constitutional system; and

**BE IT FURTHER RESOLVED**, that the DNC calls on state legislatures, independent commissions and other officials to follow the letter and the spirit of the Voting Rights Act of 1965 (as amended), and ensure that minority communities can fully participate in American politics and enjoy the opportunity to elect candidates of their choice; and

**BE IT FURTHER RESOLVED**, that the DNC advocates for strong compliance with and enforcement of the Voting Rights Act and will continue to advance and promote an open and fair system of elections for all citizens.

***Resolution in Honor of Black History Month***

**WHEREAS**, Carter G. Woodson, noted Black scholar, historian, and son of former slaves, founded the Association for the Study of Negro Life and History in 1915, which was later renamed the Association for the Study of African American Life and History; and

**WHEREAS**, Dr. Woodson initiated Black History Week on February 12, 1926, which was celebrated by Black people in the United States during the 2nd week of February (chosen so as to coincide with the birthdays of Frederick Douglass and Abraham Lincoln) for many years; and

**WHEREAS**, in 1976, as part of the nation's Bicentennial, Black History Week was expanded to establish the month of February as Black History Month, now celebrated all over North America; and

**WHEREAS**, Black History month is an opportunity for Democrats across the United States and abroad to pay tribute to the patriotism, contributions and loyal support of African Americans; and

**WHEREAS**, the Association for the Study of African American Life and History has designated the 2011 national Black History Theme as "African Americans and the Civil War," to honor the efforts of the people of African descent to destroy slavery and inaugurate universal freedom in the United States; and

**WHEREAS**, during the Civil War, free blacks and slaves rallied around the Union flag in the cause of freedom, with nearly 200,000 African Americans joining the Grand Army of the Republic and enduring unequal treatment, massacres, and riots as they pursued their quest for freedom and equality; and

**WHEREAS**, African Americans have served with honor and distinction in the defining conflicts of the last century, including the 369<sup>th</sup> Infantry that fought in the fields of France in World War I, the Tuskegee Airmen and nearly one million African Americans who served in World War II, and the more than 500 African Americans who gave their lives in Iraq and Afghanistan; and

**WHEREAS**, Barack Obama is the first elected President of African American descent; and African Americans serve in vital Cabinet and Cabinet-Level positions as Attorney General, U.S. Trade Representative, Ambassador to the United Nations, Administrator of the Environmental Protection Agency, as well as other key administrative positions; and

**WHEREAS**, according to the Joint Center for Political and Economic Studies, African American voters accounted for 10 percent of the national electorate, overwhelmingly supported Democratic candidates for the House of Representatives, and played a crucial role in Democratic victories in statewide races in New York, California, and across the nation; and

**WHEREAS**, in the 112th Session of Congress there are 44 African Americans in the U.S. House of Representatives who hold key positions as Assistant Minority Leader, and ranking members of the Judiciary, Homeland Security, Oversight and Government Reform, and Science, Space, and Technology Committees, as well as numerous sub-committees; and

**WHEREAS**, Deval Patrick, the second elected Black governor in the history of the United States of America, was reelected in 2010 as Governor of the Commonwealth of Massachusetts; and

**WHEREAS**, Kamala Harris was elected Attorney General of the State of California, Anthony Brown was reelected as the Lieutenant Governor of the State of Maryland, and Denise Nappier was reelected as State Treasurer in Connecticut; and

**WHEREAS**, African Americans are at the helm of municipalities across the country, where they hold seats in city, county and state legislatures;

**THEREFORE BE IT RESOLVED**, that the Democratic Party at all levels (national, state, and local) recognize and honor African Americans for their leadership in helping to end slavery; their historic contributions in preserving the Union; and their continuing service and sacrifice to our government and our nation; and

**BE IT FURTHER RESOLVED**, that the Democratic National Committee in respect of the contributions of the African American community and the investments they have made to our Party, shall continue to work with Democratic leaders in the U.S. House, U.S. Senate,

Democratic Governors and other state and local officials to expand the participation of all minorities and other historically under-represented groups in the political process.

*Resolution Honoring the Holodomor Victims, Survivors and Their Families*

**WHEREAS**, the Holodomor (Famine-Genocide) in Ukraine, perpetrated by the totalitarian government of the Soviet Union and its dictator Joseph Stalin in 1932-33 was one of the greatest crimes in history;

**WHEREAS**, the Soviet Government deliberately seized the entire grain harvest in Ukraine during the final phase of Stalin's collectivization policy in the First Five Year Plan;

**WHEREAS**, this action resulted in widespread starvation throughout the countryside in Soviet Ukraine;

**WHEREAS**, Soviet dictator Joseph Stalin ordered the borders of Ukraine sealed to prevent anyone from escaping the man-made starvation;

**WHEREAS**, the deliberate starvation of the Ukrainian population in the countryside was accompanied by mass arrests, executions and deportations to Siberia of thousands of people from Ukraine's cultural, political and religious sectors;

**WHEREAS**, the Soviet government manipulated and censored foreign journalists to prevent news of the man-made famine from being communicated to the world;

**WHEREAS**, New York Times correspondent Walter Duranty knowingly denied the existence of the famine, even as he privately said the Famine had claimed as many as 10 million victims;

**WHEREAS**, Soviet dictator Joseph Stalin used the same number of victims when he told British Prime Minister Winston Churchill about his campaign to impose collectivization;

**WHEREAS**, Holodomor scholar Robert Conquest conservatively estimates 7 million victims of the Famine, including those of non-Ukrainian nationalities;

**WHEREAS**, the 1988 Report to Congress of the United States Commission on the Ukraine Famine estimates that upwards of 8 million or more victims of the Holodomor;

**WHEREAS**, after exhaustive study the United States Commission on the Ukraine Famine concluded that the victims of the Holodomor were “starved to death in a man-made famine” and that “Joseph Stalin and those around him committed genocide against Ukrainians in 1932-33”;

**WHEREAS**, on November 8, 2008 the Ukrainian Parliament (Rada) determined the Holodomor to be a deliberate policy of Genocide against the Ukrainian nation, orchestrated by Joseph Stalin and the Soviet government;

**WHEREAS**, on October 13, 2006 the President of the United States signed into law P.L. 109-340 authorizing the Government of Ukraine to “establish a memorial on Federal land in the District of Columbia to honor the victims of the Ukrainian Famine-Genocide of 1932-33”;

**WHEREAS**, the U.S. House of Representatives on September 23, 2008 passed H.Res. 1314 to commemorate the 76<sup>th</sup> Anniversary of the Holodomor with 7-10 million victims;

**WHEREAS**, President Barack Obama recognized the 76<sup>th</sup> Anniversary of Holodomor Remembrance Day stating that “remembering the victims of the man-made catastrophe of Holodomor provides us an opportunity to reflect upon the plight of all those who have suffered the consequences of extremism and tyranny around the world. We hope that the remembrance of Holodomor will help prevent such tragedy in the future;”

**THEREFORE BE IT RESOLVED** that The Democratic National Committee extend its sympathies to the victims, survivors and families affected by the Holodomor and join the Ukrainian-American community and its friends in condemning the atrocity perpetrated by the Soviet Government and encouraging appropriate commemoration of this crime and its victims, including construction of the monument authorized by the Congress of the United States and signed into law by the President as P.L. 109-340.

**WHEREAS**, Richard Holbrooke was born in New York, New York, on April 24, 1941, and

**WHEREAS**, he received an A.B. from Brown University in 1962; and

**WHEREAS**, shortly after graduating from Brown, Holbrooke entered the Foreign Service; and

**WHEREAS**, a year later, after Vietnamese language training, he was sent to Vietnam, where he first served in the Mekong Delta, as a civilian representative for the Agency for International Development and then in the U.S. Embassy in Saigon, where he was staff assistant to Ambassadors Maxwell Taylor and Henry Cabot Lodge, Jr.; and

**WHEREAS**, President Lyndon Johnson asked Holbrooke, at the age of 24, to join a team of Vietnam experts at the White House; and

**WHEREAS**, Holbrooke then served as a special assistant to Under Secretaries of State Nicholas Katzenbach and Elliott Richardson; and

**WHEREAS**, he was asked to be part of the American delegation to the 1968 Paris peace talks; and

**WHEREAS**, he drafted a volume of the Pentagon Papers, a top-secret report on the government's decision-making in Vietnam; and

**WHEREAS**, in 1969, Richard Holbrooke spent a year as a mid-career fellow at the Woodrow Wilson School at Princeton University; and

**WHEREAS**, in 1970, he was appointed Peace Corps Director in Morocco, where he served for two years before being named managing editor of the magazine *Foreign Policy*; and

**WHEREAS**, in 1976, he left *Foreign Policy* to serve as campaign coordinator for national security affairs for Jimmy Carter's presidential campaign and on March 31, 1977 became Assistant Secretary of State for Eastern Asian and Pacific Affairs; and

**WHEREAS**, in January 1981, Holbrooke left government service and joined Lehman Brothers, where he worked until 1993; and

**WHEREAS**, President Bill Clinton appointed Richard Holbrooke Ambassador to Germany in 1993, where he helped shape U.S. relations with a new Germany after reunification; and

**WHEREAS**, Richard Holbrooke returned to Washington in 1994 to become assistant secretary of European Affairs; and;

**WHEREAS**, in 1996 he was awarded the Manfred Wornier Medal by the German Ministry of Defense for public figures who have rendered special meritorious service to peace and freedom in Europe; and

**WHEREAS**, after leaving the State Department in 1996, Holbrooke joined Credit Suisse First Boston, where he eventually became Vice Chairman; and

**WHEREAS**, during this period Holbrooke was asked by President Clinton to become, as a private citizen, a special envoy to Cyprus and the Balkans where he worked to end the conflict between the armed forces of Serbia and the Kosovo Liberation Army; and

**WHEREAS**, in August 1999, Richard Holbrooke was appointed U.S. Ambassador to the United Nations, where he pushed for more peacekeeping forces and drew attention to conflicts in Africa; and

**WHEREAS**, after leaving the U.N., Holbrooke took over the Global Business Council on HIV/AIDS, a non-governmental organization intended to mobilize businesses and corporations in the fight against AIDS and over the next six years turned it into a worldwide organization with over 225 members; and

**WHEREAS**, in January 2009, Richard Holbrooke was appointed by President Barack Obama as special representative for Afghanistan and Pakistan; and

**WHEREAS**, on December 11, 2010, he was admitted to George Washington University Hospital in Washington, D.C., where he underwent 20 hours of surgery to repair an aortic dissection and on December 13, 2010, Richard Holbrooke died from complications of the torn aorta; and

**WHEREAS**, President Barack Obama described Richard Holbrooke as “a truly unique figure who will be remembered for his tireless diplomacy, love of country, and pursuit of peace”;

**THEREFORE BE IT RESOLVED**, that the Democratic National Committee honor Richard Holbrooke for his contributions to our nation and offer its condolences to his family.

**WHEREAS**, after retiring from the U.S. House of Representatives in 2000, Mr. Pickett focused on developing real estate and continued to serve the Commonwealth and the people of Virginia in important capacities, including as Co-Chair of the Virginia Commission on Base Retention; and

**WHEREAS**, on October 27, 2010, Owen Pickett died at his home in Virginia Beach of congestive heart failure at the age of 80;

**THEREFORE BE IT RESOLVED** that the Democratic National Committee honor Owen Pickett for his contributions to the Commonwealth of Virginia and offer its condolences to his family.

*Resolution Honoring the Life and Career of Ronald W. Walters*

**WHEREAS**, Ronald Walters was born in Wichita, Kansas on July, 20, 1938; and

**WHEREAS**, he graduated from Fisk University in 1963, received a master's degree in African studies in 1966 from American University, and a doctorate in international studies in 1971 from American University; and

**WHEREAS**, Ronald Walters was one of the country's leading scholars on the politics of race; and

**WHEREAS**, he was also an activist who lead what many historians consider the nation's first lunch-counter sit-in protest at the Dockum drugstore in Wichita in July 1958; and

**WHEREAS**, he taught at Syracuse University in the late 1960s and became the first chairman of Afro-American studies at Brandeis University in Boston before joining the faculty at Howard University in the early 1970s, where he rose to the position of chairman of the political science department; and

**WHEREAS**, Ronald Walters helped develop the intellectual framework of the Congressional Black Caucus (CBC) and worked as a top advisor of Rep. Charles Diggs (D-MI), the first chairman of the CBC; and

**WHEREAS**, in 1977, he was a founder of the TransAfrica Forum, a group that led the fight against South African apartheid and sought to improve conditions in Haiti; and

**WHEREAS**, Dr. Walters was a founder and Board Member of the National Coalition on Black Civic Participation, an organization dedicated to increase Black civic engagement and voter empowerment; and

**WHEREAS**, Ronald Walters served as a confidant, strategic advisor on issues, the platform committee, rules and bypass committee, during the historic and ground breaking campaigns of Rev. Jesse Jackson in both 1984 and 1988; and

**WHEREAS**, Ronald Walters was the author of over 100 articles and thirteen books and his book, *Black Presidential Politics in America*, won the Ralph Bunche Prize given by the American Political Science Association and became the blueprint for the presidential campaign of Rev. Jesse Jackson; and

**WHEREAS**, Dr. Walters served as director of the African American Leadership Institute and a distinguished scholar at the James MacGregor Burns Academy of Leadership at the University of Maryland from 1996 until his retirement in 2009; and

**WHEREAS**, he was a sought-after commentator and columnist on political issues, authoring weekly columns for the Washington Informer and the Richmond (Va.) Free Press that eventually were syndicated to other black newspapers through the National Newspaper Publishers Association News Service; and

**WHEREAS**, when Hurricane Katrina devastated New Orleans in 2005, Dr. Walters became a leading voice in highlighting the inequality that tarnished the American Dream; and

**WHEREAS**, one of seven children, Ron Waters was the eldest son of Maxine and Gilmar “Butter” Walters; his father, a retired civil servant, a “Buffalo Soldier,” and a Tuskegee Airman, was also a professional musician; and his mother was a Kansas state civil rights investigator; and

**WHEREAS**, Dr. Walters is survived by his wife of 47 years, Patricia Turner Walters, who resides in Silver Spring, MD; his brothers: Duane in Atlanta, GA; Terry in Oklahoma City, OK; Kevin in Bowie, MD; and sisters: Marcia in Austin, TX; and Sharon in Atlanta, GA; a host of relatives in KS, CA, MI, CO, IL, etc., and cherished friends and colleagues;

**WHEREAS**, on September 10, 2010, Ronald Walters died of cancer at Suburban Hospital in Bethesda, Maryland at the age of 72;

**THEREFORE BE IT RESOLVED**, that the Democratic National Committee honor Dr. Ronald Walters for his contributions to the historic struggle for both civil and voting rights and the study of political science, Black leadership in the twentieth century and political empowerment for all Americans.

**WHEREAS**, Mary Peyton Chambers lived a life of generosity and warmth to her friends and family, commitment to helping the lives of children and working families, and brought great exceptional political acumen to the great state of New Hampshire as a political leader ; and

**WHEREAS**, Mary Peyton Chambers served on the NH Democratic State Committee for thirty eight years, serving in many positions including state party vice-chair from 1993-1997; and

**WHEREAS**, she served as a member of the Democratic National Committee from 1988 to 1997, and served as a delegate to the 1980, 1984, 1988, 1992 and 1996 Democratic National Conventions, and served as NH delegation chair in 1984 and 1988 of the NH delegations to the 1984; and

**WHEREAS**, she served as a member of the Professional Conduct Committee of the NH Supreme Court, and was appointed by President Carter to serve on the National Council for the Handicapped in 1980, and

was a NH Presidential Elector for President Clinton in 1992 and served as chair of the NH Sweepstakes Commission appointed by Governor Jeanne Shaheen; and

**WHEREAS**, Mary Peyton Chambers has been the recipient of many awards for her tireless work on behalf of the people of the State of New Hampshire and has served as a constant source of inspiration and guidance over years for people across the Granite State; and

**WHEREAS**, Mary Peyton Chambers passed away Saturday, November 20, 2010, in Lebanon, New Hampshire at the age of 79;

**WHEREAS**, he co-founded the Jesse M. Unruh Institute of Politics at USC where thousands of students have received a real education in politics, beyond the normal academic teaching; and

**WHEREAS**, in over 50 years in political life, Joe Cerrell made a lasting contribution to the vitality of the Democratic Party of the United States by mentoring generations of young people and helping elect Democrats at all levels of service to our country; and

**WHEREAS**, he was also a proud Italian-American, serving as president of the Italian-American National Foundation, which led him to being named a Knight of Italy; and

**WHEREAS**, on December 3, 2010, Joseph R. Cerrell passed away at the age of 75, following complications from pneumonia;
