## Resolution in Support of President Biden and his Historic Agenda

**WHEREAS,** President Biden and congressional Democrats took historic action to deliver results for the American people, with one of the most legislatively productive Congresses ever; and

**WHEREAS**, President Biden signed into law the Inflation Reduction Act, which will lower the cost of prescription drugs, health care, and energy – all while reducing the federal deficit and finally making big corporations pay their fair share; and

WHEREAS, middle-class families making below \$400,000 won't pay a dime more in taxes; and

WHEREAS, this law is also the most meaningful legislation ever to address the climate crisis; and

**WHEREAS**, Congressional Democrats passed the president's American Rescue Plan – without a single Republican vote – helping create millions of jobs, funding our vaccination campaign, reopening schools, and getting our country back on track; and

WHEREAS, President Biden signed into law the Bipartisan Infrastructure Law to make the largest investment in infrastructure improvements in decades, including substantial funding to rebuild roads and bridges, expand high-speed internet access, strength supply chains, and combat the climate crisis – all while creating thousands of good-paying jobs, strengthening our unions, and putting America on track to lead the world in the 21st century; and

**WHEREAS,** President Biden signed the CHIPS and Science Act into law to lower costs, create American jobs, and increase competitiveness with China; and

**WHEREAS,** President Biden signed the PACT Act into law to ensure veterans exposed to toxic burn pits get the health care benefits they've earned; and

**WHEREAS,** President Biden is the first president to bring both parties together to take the most meaningful action on gun violence in 30 years; and

WHEREAS, this White House has also made history by confirming Justice Ketanji Brown Jackson as the first Black woman on the Supreme Court, and has earned confirmation of 75 judicial nominees, the most federal court nominees confirmed through this point in his term of any president since John F. Kennedy. These highly qualified appointments also reflect the diversity of our country - as three-quarters of the administration's confirmed nominees identify as women and nearly two-thirds identify as people of color; and

WHEREAS, President Biden led a successful counterrorism mission against Ayman al-Zawahiri, an Al-Qaeda leader who was in part responsible for the devastating 9/11 attack on our country; and

**WHEREAS,** President Biden's leadership to bring down costs has led gas prices to have had the fastest gas price decline in over a decade this summer; and

**WHEREAS**, thanks to President Biden's leadership we now have one of the best job markets in history. In July 2022, the unemployment rate matched a 50-year low at 3.5% and all the jobs lost at the beginning of the pandemic have now been recovered; and

**WHEREAS**, Congressional Republicans have sided with special interests, stood in the way of this progress, and pushed an extreme MAGA agenda that could cost families;

**THEREFORE, BE IT RESOLVED,** that the Democratic National Committee applauds President Biden for delivering transformational, legacy-defining results and building a better America for working families; and

**BE IT FURTHER RESOLVED,** that the Democratic National Committee expresses our full and complete support for President Biden, Vice President Kamala Harris and the Biden administration.

Resolution Reaffirming Our Commitment to Reproductive Justice, Privacy Rights, and Personal Freedoms and Support of Codifying Abortion Rights

**WHEREAS**, it is clear that there is an extreme Republican assault on Americans' basic freedoms, from privacy rights to contraception to reproductive choices to marriage equality, rendering our children with fewer rights than their parents had; and

WHEREAS, the extreme Supreme Court's decision to overturn *Roe v. Wade* was a devastating blow to Americans' fundamental freedom to make their own health care decisions, is a direct result of Republicans' unrelenting, decades-long, radical war on health care and womens' right to choose and was the first time the Supreme Court took away an individual right it had previously granted; and

WHEREAS, the doctrine of stare decisis is a key underpinning of the rule of law because stare decisis is grounded in the notion that our rights and liberties depend on a predictable set of norms that will be safeguarded by the courts and since *Griswold v. Connecticut* in 1965, a fundamental precept in our nation's laws has been that each of us has a fundamental right to privacy and to the bodily autonomy to make our own decisions; and

**WHEREAS**, the recent string of Court decisions disregarding decades of precedent poses a grave threat to the fundamental rights of all Americans, but the abrogation of the rights of women and curtailment of gender equality brought about by the *Dobbs* decision is the most immediate and tragic; and

**WHEREAS**, the ruling that overturned *Roe v. Wade* is causing immense and irreparable harm to patients across America, including:

- people being legally unable to choose whether to have children
- miscarriages treated as murders and mourning parents treated as criminals
- women bleeding out on hospital tables while their doctors are forced to wait until their lives are sufficiently in danger to address their high-risk pregnancies
- transgender and non-binary patients facing medical discrimination on top of draconian abortion bans
- fertility treatments, such as IVF, is being threatened in some states
- child rape victims as young as 10 years old being retraumatized and refused care
- Black, Native, immigrant, disabled, rural and low-income women who already have the
  nation's highest maternal morbidity rates and health care disparities now losing access to
  medically accurate, culturally competent, linguistically appropriate reproductive services;
  and

**WHEREAS**, extreme MAGA Republicans have vowed to federally ban abortion if they retake power; and

**WHEREAS**, the vast majority of Americans oppose the overturning of *Roe* and believe the Supreme Court's ruling is a step backward for America; and

**WHEREAS**, voters in Kansas sent a message to the nation and proved once again that abortion rights are a galvanizing and popular issue among voters, defeating Republican efforts to try to remove abortion rights from their state constitution; and

WHEREAS, the Democratic party, President Biden, and congressional Democrats are responding to this public health crisis with actions at all levels of government, starting with the Biden-Harris administration's executive orders and task forces to support patients' rights and support patients traveling out of state for medical care; access to reproductive health care, including fertility treatments, contraception and abortion; health care providers' safety and well-being; patients' data privacy; freedom to travel; and access to emergency medical care; and

WHEREAS, the Democratic U.S. House of Representatives passed bills affirming the right to choose, the right to contraception, the right to travel, and the right to same-sex and inter-racial marriage equality, and voted to codify Roe v. Wade and enshrine its protections in federal law — with the vast majority of House Republicans voting NO and vowing a national abortion ban if they seize control of Congress; and

**WHEREAS**, Democratic senators voted twice to advance legislation to codify Roe v. Wade but were blocked by Republican filibusters; and

**WHEREAS**, Democrats will not give up the fight for abortion rights and Americans' personal freedoms, and Republicans' MAGA agenda is wildly out of touch and unpopular with the American people; and

**WHEREAS**, until Congress restores protections of *Roe* as federal law, President Biden is doing everything in his power to defend reproductive rights and protect access to safe and legal abortion;

**THEREFORE, BE IT RESOLVED,** that the Democratic National Committee affirms our commitment to reproductive justice, privacy rights, and personal freedoms, and supports the continued efforts of President Biden, Vice President Harris, Democrats in Congress, governors, attorneys general, and state legislators across the country to defend reproductive freedoms from Republican attacks and notes that failing to stand up for this principle threatens the freedom, health, and safety of women everywhere; and

**BE IT FURTHER RESOLVED**, that the Democratic National Committee believes that we must codify *Roe v. Wade* into law, and agrees with President Biden that "if the filibuster gets in the way, it's like voting rights, we provide an exception for this. We provide an exception of the filibuster for this action;" and

**BE IT FURTHER RESOLVED** that the Democratic National Committee supports the Biden-Harris administration and Democratic governors' executive orders and task forces to

support our basic fundamental right to choose the size and timing of our families, and our rights to contraception, to abortion access, to health equity, and to marriage equality; and

**BE IT FURTHER RESOLVED,** that the Democratic National Committee urges all Members of this body, Delegates, Democrats and all elected officials to push to elect more Democrats in order to enshrine abortion rights into law, and allow all Americans to decide if and when to start a family, marry the person they love, and live free from discrimination no matter who they are; and

**BE IT FURTHER RESOLIVED**, that the Democratic National Committee stands in support of the rights of women to control their own bodies and the rights of adults to marriage equality, have relationships with other adults regardless of sexual orientation or gender identity, and supports the principle that stare decisis should continue to be followed by all U.S. courts.

## Resolution Supporting President Biden's Leadership on the Economy

**WHEREAS**, President Biden campaigned on a promise to not only help America recover from the pandemic, but build our economy back even better than before, from the bottom up and the middle out; and

**WHEREAS**, while there is still work to be done, President Biden, Vice President Harris, and Democrats in Congress have led the United States to one of the fastest economic recoveries in history; and

**WHEREAS**, President Biden and Democrats' American Rescue Plan, which not a single Republican in Congress voted for, helped get over 220 million Americans vaccinated, keep small businesses open, provide relief to working families, safely reopen schools, and create millions of jobs; and

**WHEREAS**, the Biden-Harris administration has taken aggressive action to lower the costs that families face, including by helping ease supply chain bottlenecks, bolstering domestic manufacturing, and promoting competition to ensure lower prices for consumers and fairer wages for workers; and

WHEREAS, despite unanimous opposition from Republicans, President Biden and congressional Democrats delivered a major win over Big Pharma and special interests by passing the Inflation Reduction Act, which will save 13 million Americans \$800 per year on health care costs, cap the costs of prescription drugs for seniors, save American families \$500 per year on energy bills, create good-paying jobs across the country, and ensure that the wealthiest and largest corporations pay their fair share in taxes while no one earning less than \$400,000 a year will see their taxes raised a single cent; and

WHEREAS, the average national gas price has dropped at the fastest rate in over a decade thanks in large part to President Biden's aggressive action to address Putin's price hike at the pump and the president has promised to continue to call on domestic and international oil producers to increase output so prices can continue to decline;

**THEREFORE, BE IT RESOLVED**, that the Democratic National Committee supports the economic leadership of President Biden, Vice President Harris, and Democrats in Congress, and their plans to continue economic recovery from the pandemic; and

**BE IT FURTHER RESOLVED,** that we affirm that President Biden is keeping his promise to build back better from the pandemic and foster an economy that works for all Americans.

#### Resolution in Support of the Equal Rights Amendment

WHEREAS, the United States of America is the only industrialized country that does not explicitly recognize the equality of women in its constitution, and 94% of constitutions adopted since 1970 include a rule establishing the equality of women. However, women continue to confront workplace discrimination; wage inequities; health care inequities; higher rates of poverty, rape and domestic violence assaults; a lack of political parity; and other forms of sex-based discrimination; and

WHEREAS, Article 5 of the U.S. Constitution sets out two requirements for amendments: approval by two-thirds of both chambers of Congress, and ratification by 3/4 (38) of the states, and on January 27, 2020, the Equal Rights Amendment (ERA) finally achieved both requirements, but an Office of Legal Counsel (OLC) opinion issued under the Trump administration was used to block the certification and publication of the amendment; and

**WHEREAS**, on January 27 2022, President Biden issued a statement calling on Congress to act immediately to pass a resolution recognizing ratification of the ERA following a new OLC opinion that the previous opinion was not an obstacle to congressional action on ratification;

**THEREFORE, BE IT RESOLVED**, that the Democratic National Committee reaffirms its strong support for strategic efforts to validate the passage of the ERA to guarantee that "equality of rights under the law shall not be denied or abridged by the United States or by any State on account of sex."

## Resolution Recognizing the 40th Anniversary of the Murder of Vincent Chin

WHEREAS, June 23, 2022, marked the 40th anniversary of the murder of Vincent Jen Chin, while the country has seen an unprecedented escalation of anti-Asian hate incidents and crimes; and

WHEREAS, Chin, a United States (US) citizen of Chinese descent, lived in Michigan during an economic recession when factories were being closed and workers were being laid off, leading some to blame Japanese automobile imports for the challenges facing the US automobile industry and strong anti-Japanese sentiments, including acts of vandalism against Japanese cars, threats against Japanese car owners, disparaging signs, and attempts to burn the Japanese flag in protest; and

WHEREAS, Chin, who was celebrating his upcoming wedding with friends in the Detroit area, was chased down and beaten to death with a baseball bat by two men who accused him of being responsible for the loss of automobile manufacturing jobs in the United States; and

WHEREAS, Chin's killers were found guilty of manslaughter and sentenced to 3 years of probation and a \$3,000 fine, never serving a day in jail for his murder; and

WHEREAS, the lessons of Chin's death still hold critical relevance today as we address the ongoing challenges of hate crimes, profiling, xenophobia, and bullying; and

WHEREAS, it was anti-Asian hate that fueled the Chinese American Exclusion Act of 1882, the imprisonment of 120,000 innocent Japanese Americans during World War II, and attacks targeting Muslim, Middle Eastern, Arab, Sikh, and South Asian communities after 9/11; and

WHEREAS, in 2021, anti-Asian hate crimes increased by 339 percent, and in 2020, they increased by 124 percent, with over 11,000 anti-Asian hate incidents reported to Stop AAPI Hate since March 2020, countless unreported and many who lost their lives; and

WHEREAS, a recent survey found that between 2021 and 2022, Americans have become more likely to suspect that Asian Americans are more loyal to the countries they or their families immigrated from than the United States; and

WHEREAS, the most recent wave of anti-Asian hate stems not only from the pandemic but also from broader rhetoric around economic competition with China, mirroring the hate that fueled the brutal attack that killed Vincent Chin; and

**WHEREAS,** history is once again repeating itself as anti-Asian hate rises in a time of economic anxiety;

#### **THEREFORE**, **BE IT RESOLVED**, that the Democratic National Committee:

- 1. recognizes the significance of the 40th anniversary of Vincent Chin's death as an important time to reflect on the dangers of xenophobia and scapegoating of Asian and Asian-American communities;
- 2. recognizes that anti-Asian hate continues to plague our country;
- 3. mourns all those who have lost their lives to anti-Asian hate; and
- 4. calls for an end to hate crimes/incidents, profiling, xenophobia, and bullying.

#### Resolution in Consideration of HR 669 and S 1148 to Restrict the First Use of Nuclear Weapons

WHEREAS, nuclear weapons are uniquely powerful with the capability of instantly killing millions of people, most if not all innocent people, and to create long-term health and environmental damage throughout the world. These weapons undermine global peace and place the United States (US) at existential risk from retaliatory nuclear strikes; and

WHEREAS, global spiritual leaders note that nuclear weapons exist in the service of a mentality of fear that affects not only the parties in conflict but the entire human race, so real priorities such as the fight against poverty, the promotion of peace, and the undertaking of educational, ecological, and health care projects are relegated to second place; and

WHEREAS, according to the DNC platform, "Democrats believe the United States has a moral responsibility and national security imperative to prevent the spread of nuclear, chemical, and biological weapons, and eventually secure their elimination;" and

**WHEREAS**, the framers of the US Constitution understood that the monumental decision to go to war must be made by the representatives of the people in Congress and not by a single person by giving Congress the sole power to declare war and by definition, a first-use strike by the US constitutes an act of war: and

WHEREAS, section 2(c) of the War Powers Resolution (Public Law 93–148; 50 U.S.C. 1541), states "the constitutional powers of the President as Commander-in-Chief to introduce United States Armed Forces into hostilities, or into situations where imminent involvement in hostilities is clearly indicated by the circumstances, are exercised only pursuant to (1) a declaration of war, (2) specific statutory authorization, or (3) a national emergency created by attack upon the United States, its territories or possessions, or its armed forces"; and

WHEREAS, the best time to codify this resolution is before the US has a President who might issue the order to use a nuclear weapon, an order which military officers of the US must carry out in accordance with their obligations under the Uniform Code of Military Justice; and

**WHEREAS**, stalwarts of the House of Representatives like Speaker Pelosi and Congresswoman Lee have previously led on this issue and the House of Representatives has passed identical "Restricting First Strike of Nuclear Weapons Act" bills in prior sessions; and

WHEREAS, the Restricting First Use of Nuclear Weapons Act of 2021, cosponsored by 43 members of Congress as House Resolution 669 (Lieu-CA) and cosponsored by 8 Senators as S.1148 (Markey- MA) embodies a policy of no first use of nuclear weapons without a Congressional Declaration of War and require a specific authorization by Congress for first use of nuclear weapons without limiting retaliation for another party's first use;

**THEREFORE, BE IT RESOLVED**, that the DNC acknowledges the urgency to take action, while the Democrats hold the majority in the House and US Senate and hold the White House to address restricting the first use of nuclear weapons so a President would not be able to initiate the first use alone.

**THEREFORE, BE IT RESOLVED,** that the Democratic National Committee urges the HHS to expedite the transfer of funds for radiological research to NIAID's Radiological Counter Measures Program.

## Resolution in Support of Policies to Address Poverty and Systemic Racism in the United States

**THEREFORE, BE IT RESOLVED**, that Congress should pass legislation to strengthen the public financing system; and

**BE IT FURTHER RESOLVED,** that the Democratic National Committee remains committed to passing a constitutional amendment to overturn *Citizens United*; and

**BE IT FURTHER RESOLVED**, that the Democratic National Committee reaffirms its support for banning corporate PACs from donating to candidates, and barring lobbyists from donating or fundraising for anyone they lobby; and

## Resolution to Consider an Award of Executive Clemency for Leonard Peltier

**WHEREAS**, Democrats have sought to use clemency powers to secure the release of those serving unduly long or unjust prison sentences; and

WHEREAS, the Obama administration commuted the sentences of more than 1,700 people serving unjust sentences after a thorough review of their individual cases and the Biden administration has so far used clemency powers for more than 75 individuals serving unjust sentences as part of a broader strategy to make the criminal justice system more fair; and

**WHEREAS**, the Biden administration, under the direction of Secretary Deb Haaland, is leading a historic investigation into the lasting social impacts — such as, historical and intergenerational trauma — of the federal Indian boarding school system that separated Mr. Peltier from his family at a young age; and

**WHEREAS**, Mr. Peltier is 77 years old, and has served more than 45 years in federal prison – at least five years solitary confinement – in numerous prisons across the United States; and

WHEREAS, Leonard Peltier is Native American, elderly and suffers from severe health conditions, including diabetes and a lethal abdominal aortic aneurysm; life ending if ruptured; and

WHEREAS, The Department of Justice (DOJ) has issued a national response to the COVID-19 pandemic authorizing the Federal Bureau of Prisons (BOP) to release elderly inmates and those with underlying health conditions from federal prisons; Mr. Peltier is imprisoned at the Coleman Federal Correctional Complex in Florida and qualifies for early release under BOP guidelines; and

WHEREAS, Mr. Peltier was convicted and sentenced to two consecutive life sentences in 1977 for the murders of Federal Bureau of Investigation (FBI) agents Ronald Williams and Jack Coler, killed on June 26, 1975, during a confrontation with members of the American Indian Movement (AIM) on the Pine Ridge Indian reservation; Joseph Stuntz, a 23-year-old member of the Coeur d'Alene Tribe, was also killed that day, and his death was never investigated; and

**WHEREAS**, Mr. Peltier was extradited from Canada based on false statements of an alleged eye witness who later retracted her testimony; and

**WHEREAS**, many evidentiary and procedural irregularities arose during Mr. Peltier's prosecution, such as alleged key eyewitness to the shootings later retracting testimony disclosing threats against the eyewitness and family by the FBI; and

**WHEREAS**, a 1980 Freedom of Information Act ruling revealed to Mr. Peltier's lawyers the prosecution withheld evidence that might have impacted Mr. Peltier's case; and

**WHEREAS**, although legal experts have criticized the trial for its failed due process, appeals for presidential consideration of clemency by distinguished Americans and justice organizations have had no success; and

WHEREAS, this further diminishes American Indians' faith in the criminal justice system throughout the country; and

**WHEREAS**, hundreds of tribal nations have supported early release and clemency Mr. Peltier's throughout the years, and the Turtle Mountain Band of Chippewa, of which Mr. Peltier is a member, has offered housing, elderly support, and reintegration services upon Mr. Peltier's release; and

WHEREAS, petitions for Mr. Peltier's release are widespread and urgent, including those who once were part of the 1977 criminal prosecution and former U.S. Attorney James H. Reynolds, having garnered over 275,000 signatures on a petition requesting President Biden grant Mr. Peltier clemency; and

**WHEREAS**, Amnesty International, a global human rights organization with over 10 million members, supporters, and activists worldwide, continues the call for Mr. Peltier's release to this day; and

WHEREAS, Mr. Peltier has overwhelming support from internationally respected champions of human rights, including the late Nelson Mandela, His Holiness the Dalai Lama, Mikhail Gorbachev, Mary Robinson, former President of Ireland and United Nations High Commissioner for Human Rights, the European Parliament, the Belgian Parliament, the Italian Parliament, the Kennedy Memorial Center for Human Rights, the Rev. Jesse Jackson, Rigoberta Menchu, seven

Nobel Peace Prize Laureates (including Archbishop Desmond Tutu and Shirin Ebadi), Rage Against the Machine, Pete Seeger, Carlos Santana, Harry Belafonte, Gloria Steinem, and Robert Redford, representing but a fraction of those who recognize the injustice imposed upon Mr. Peltier; and

WHEREAS, the National Caucus of Native American State Legislators, tribal nation leaders, and the National Congress of American Indians, within our representative states and beyond, have demanded Mr. Peltier's clemency and release;

**THEREFORE, BE IT RESOLVED**, that the DNC platform states that the President should use clemency powers "to secure the release of those serving unduly long sentences;" and

**BE IT FURTHER RESOLVED,** that given the overwhelming support for clemency, the constitutional due process issues underlying Mr. Peltier's prosecution, his status as an elderly inmate, and that he is an American Indian, who suffer from greater rates of health disparities and severe underlying health conditions, Mr. Peltier is a good candidate to be granted mercy and leniency; and

**BE IT FURTHER RESOLVED**, that it is highly appropriate that consideration of clemency for Mr. Peltier be prioritized and expedited, so that Mr. Peltier can return to his family and live his final years among his people.

### Resolution Honoring the Life and Career of Zahra Abbas

WHEREAS, Zahra Abbas was born on October 22, 1986; and

**WHEREAS**, she became the first Arab American elected to serve on Michigan's Delegation to the Democratic National Committee in 2021; and

**WHEREAS**, she was committed to being a strong advocate for progressive issues within the Democratic Party. She became a leader in the Progressive Caucus, Cannabis Caucus, Disability Caucus and the Young Dems; and

WHEREAS, throughout her lifetime, served on numerous boards and civic organizations at the national, state, and local level; and

WHEREAS, the Epilepsy Foundation described her as "an advocate of a generation"; and

WHEREAS, she worked as a medical assistant and wanted to pursue a career in public health to help shape rules and regulations around health care, drug policy, and disability issues; and

**WHEREAS**, she suffered throughout her life from a very debilitating form of epilepsy that required frequent hospitalizations and surgeries and near death events, but in spite of this Zahra maintained a positive and infectious outlook and determination to stand up and commit to helping others as well as loving and supporting her family; and

WHEREAS, she was a strong activist for marijuana legalization for medical and recreational purposes, and benefitted from the administration of marijuana to help control her epilepsy; and

**WHEREAS**, she served as vice president of the Detroit chapter of the National Organization for the Reform of Marijuana Laws, Motor City NORML; and

**WHEREAS**, she was proud of her recent appointment to be in charge of Dearborn Pipers, which was a recreational program in Dearborn for special needs children; and

**WHEREAS**, she was a committed volunteer for other progressive issues such as Proposal 1 and Proposal 2 that were passed and added to the state of Michigan Constitution in 2018; and

**WHEREAS**, she worked tirelessly for progressive candidates on a state and local level in helping them get elected and in working with office holders to advocate for agendas that benefited the most needy; and

WHEREAS, her advocacy extended to criminal justice, according to the Detroit Metro Times, and "she played a pivotal role in setting up a meeting with Attorney General Dana Nessel that resulted in her writing a letter to Governor Gretchen Whitmer in support of commuting the sentence of Michael Thompson. In one of the longest sentences for a nonviolent offender in the U.S., Thompson was sentenced in 1996 for up to 60 years in prison after selling marijuana to an undercover cop. Governor Whitmer commuted his sentence in 2020"; and

**WHEREAS**, U.S. Congresswoman Rashida Tlaib held a moment of silence in honor of Zahra Abbas, calling her "an incredible warrior" on the floor of Congress; and

**WHEREAS**, as an American Muslim, she advocated for human rights at home and abroad, raising a voice for those displaced by slavery, colonialism, climate change, conflict, and migration; and

WHEREAS, she is survived by her parents Mahmoud Abbas and Sanae Hassan-Abbas and her siblings Mariam, Khouder, Hadi, Sarah, and Ahmad; and

**WHEREAS**, her last day was one of the most positive and impactful. The day before her death she worked with her children's program and then came to the Dearborn Dems picnic to meet with other local Democrats; and

**WHEREAS**, former Michigan Cannabis Caucus Chair, Progressive Activist, and DNC Member Zahra Abbas passed away on July 27, 2022, at the age of 35;

**THEREFORE, BE IT RESOLVED**, that the Democratic National Committee honors Zahra Abbas for her contributions to our country and the Democratic Party and offers its condolences to her family and to all Michiganders. Zahra Abbas was a human being who made the lives of others richer for having known her and who made every effort to improve the lives of those less fortunate.

WHEREAS, he was active in the League of United Latin American Citizens (LULAC), the largest and oldest Latino civil rights organization in the country, and the Austin Gay and Lesbian Political Caucus, founded in 1978, prior to founding allgo. He continued his activism throughout his life, working for human rights in multiple arenas. Saúl was a staunch supporter of women's rights, reproductive rights, and women's leadership. His leadership and activism exemplified the wisdom in the famous Audre Lorde quote: "There is no such thing as a single-issue struggle as we do not live single-issue lives;" and

**WHEREAS**, Saúl served as a commissioner on the Austin Human Rights Commission, a Board member on the Austin Reading is Fundamental Board of Directors, and the allgo Board of Directors for many years; and

WHEREAS, he was a member and strong supporter of El Paso in Austin, fundraising for scholarships for Latine young people as well as serving as a Community Health Champion through Central Health in his hometown; and

WHEREAS, Saúl served as the Treasurer for the governing Board of Directors of Planned Parenthood of Greater Texas and on the Lesbian, Gay, Bisexual, Transgender, and Queer Quality of Life Advisory Commission for the City of Austin. Serving as treasurer for José Orta's (a fellow allgo founder and activist) campaign for Williamson County Commissioner for Precinct 4 this year, is only one example of the myriad campaigns he has worked on throughout the years to support progressive Black and Brown elected officials; and

**WHEREAS**, he was elected as a Democratic National Delegate for SD 21 in 2016 and was never afraid to dive into the mess and heartbreak of politics with a tireless hope that change was indeed possible; and

WHEREAS, Norman Yoshio Mineta (Norman Y. Mineta) was born in San Jose, California on November 12, 1931; and

**WHEREAS**, as a young child during World War II, Norman Y. Mineta and his family were unjustly sent to Heart Mountain Relocation Camp in Park County, Wyoming by the United States government through Executive Order 9066 due to their Japanese ancestry; and

WHEREAS, Norman Y. Mineta returned to San Jose with his family after World War II, graduated from San Jose High School, and earned a degree in business administration from the University of California, Berkeley; and

**WHEREAS**, Norman Y. Mineta honorably served as a United States Army intelligence officer in Japan and Korea before returning home and joining the insurance business run by his father; and

**WHEREAS**, in 1967, Norman Y. Mineta became the first person of color to serve on the San Jose City Council and, in 1971, was elected as the 59th mayor of San Jose, becoming the first Asian American to serve as mayor of a major city in the United States; and

**WHEREAS**, Norman Y. Mineta was elected to the United States House of Representatives in 1974, where he served as president of the freshman class and went on to spend more than 20 years, during which time he never forgot a name; and

WHEREAS, Norman Y. Mineta was a champion of civil rights and co-sponsored the Civil Liberties Act of 1988 (50 U.S.C. 4211 et seq.), which (1) was signed into law; and (2) expressed a formal apology to the thousands of individuals of Japanese ancestry in the United States who were incarcerated into camps during World War II and offered \$20,000 payments to each living individual; and

**WHEREAS**, Norman Y. Mineta distinguished himself as an expert on transportation issues and an advocate for mass transit, serving as chairman of the Committee on Transportation and Infrastructure of the House of Representatives; and

**WHEREAS**, Norman Y. Mineta entered the private sector after leaving Congress, but continued to serve the United States as chairman of the National Civil Aviation Review Commission; and

WHEREAS, Norman Y. Mineta was nominated by President William J. Clinton in 2000 to serve as the United States secretary of commerce, being the first Asian American to serve as a cabinet secretary; and

WHEREAS, Norman Y. Mineta was nominated by President George W. Bush in 2001 to serve as the United States Secretary of Transportation, where during the tragic day of September 11, 2001, he secured the airspace of the continental United States by ordering all civilian air traffic to land immediately and implemented new security protocols to ensure the safety of air travelers; and

WHEREAS, Norman Y. Mineta was known for his warm personality, commitment to public service, accessibility and accountability, passion for his work, with unparalleled integrity and modesty;

**THEREFORE BE IT RESOLVED**, that the Democratic National Committee honors the life of Norman Y. Mineta for his contributions for our country and the Democratic Party, and offers its condolences to his family and friends.

**WHEREAS**, in 1992, she became Delaware's first female Lieutenant Governor, serving for eight years; and

**WHEREAS**, throughout her career in public service, Governor Minner advocated for education, health care, and the environment; and

**WHEREAS**, Governor Minner signed landmark legislation creating the SEED (Student Excellence Equals Degree) Scholarship Program, which made Delaware the first state to offer free college access for students; and

**WHEREAS**, to protect the health of Delawareans, Governor Minner signed the Clean Indoor Air Act, banning smoking in most public indoor places, including restaurants, bars, and casinos; and

WHEREAS, Governor Minner passed away on November 4, 2021; and

**WHEREAS**, Governor Minner leaves a legacy of dedicated public service and her efforts had a positive impact on the lives of thousands of Delawareans;

Resolution In Support Of The Biden-Harris Administration's Targeted Student Loan Debt Relief
